


Integrated System



- The UK is a world leader in evidence-based diabetes programmes, and a trailblazer in our approach to prevention. We are home to many innovative tech companies with solutions for self-management.
- The UK has more experience than anyone in designing integrated, evidence-based pathways and delivering services centred around patient outcomes, especially for older people.
- The UK is an innovator in fertility services, leading advances in the use of Pre-implantation

Genetic Screening, Mitochondrial Donation and Cryopreservation. We do this whilst maintaining high levels of safety: the rate of risky multiple births has fallen by 13% over the last 18 years through promotion of single embryo transfer.

- The UK is a world-leader in the development of genomic medicine, developing treatments and diagnostics which are revolutionising patient care. Genomics England is undertaking the 100,000 Genomes Project to sequence the entire human genome, one of the largest of its kind in the world.
- The UK has a highly effective urgent and emergency care system, with 27 specialised Major Trauma Centres. The London Trauma Centre increased survival rates by 50% between 2010-2015.
- The UK is a leader in mental health, in both adult and children & young people's services, with the lowest rate of suicide post-discharge of all 35 OECD countries.

The foundation for excellent healthcare

- UK engineering and design firms are experts in what most countries need tomorrow including sustainability in projects, longterm resilience, whole-life cost efficiency, and embedded environmental, social and governance (ESG), focus on value, cost management and advanced programme management skills to de-risk and reduce project costs, technical innovations such as in geophysics and electrical design for proton beam centres, and designing for change in clinical services
